Sprayer Preparation:

- Ensure proper clean out of spray equipment, prior to using Gramoxone[®] SL 2.0 herbicide
- For ground application, consider use of higher spray volumes: a minimum of 20 GPA, if possible
- Surfactants:
 - Use a surfactant that meets the requirements of the Chemical Producers and Distributors Association (CPDA) adjuvant certification program

• Nonionic Surfactant (NIS):

 Ground or Aerial Application: NIS containing 80% or more surface-active agent at a minimum of 0.25% v/v (2 pt/100 gal)*

• Crop Oil Concentrate (COC) or Methylated Seed Oil (MSO):

- ◆ Ground Application: COC or MSO containing 15-20% approved emulsifier, at 1.0% v/v (1 gal/100 gal) of the finished spray volume
- Aerial Application: COC at 1 pint per acre.
 Do not use COC when using Gramoxone SL 2.0 for cotton harvest aid
- * When tank mixing with fomesafen-containing products, such as Reflex[®] herbicide, use the following rate of NIS: 1% v/v at <=10 GPA, 0.5% v/v at >10GPA

Mixing Order:

- 1. Fill spray tank 1/2 full with clean water or other approved carriers such as clear liquid fertilizer
- 2. Begin tank agitation and continue throughout mixing and spraying
- 3. Nonionic surfactant (NIS)
- 4. Dry formulations (WP, DF, etc.)
- 5. Liquid formulations (SC, EC, L, etc.)
- 6. Gramoxone SL 2.0
- 7. Crop oil concentrate (COC) or methylated seed oil (MSO) where needed
- 8. Fill remainder of spray tank
- Refer to labels of other pesticide products for mixing directions and precautions which may differ from those outlined here
- Perform a tank-mix jar-test to ensure compatibility prior to preparing any tank mix that has <u>not previously been</u> <u>verified as compatible</u>
- In the case of incompatibility in the tank-mix jar-test, repeat the test with the addition of a compatibility agent at the manufacturer's recommended rate, before adding NIS
